The Candidate has borrowed a like amount from the Colorado National Bank pursuant to a loan agreement and promissory note, copies of which are attached here as exhibits "c" & "d".

The parties have agreed that the terms and conditions of the loan from the Candidate to the committee shall be in all material respects the same as the terms of the loan from the bank to the Candidate.

320,000.00 was drawn during this reporting period by the Candidate from the bank. This amount was loaned by the Candidate to the Committee.

Note 2

The interest rate is 1% point above the Colorado National Bank Reference Rate.

LOAN AGREEMENT BETWEEN FRIENDS OF TOM STRICKLAND, INC. AND THOMAS L. STRICKLAND

THIS AGREEMENT is made effective July 8, 1996, between Friends of Tom Strickland, Inc. (the "Committee") and Thomas L. Strickland ("Strickland").

RECITALS

- A. The Committee desires to borrow funds from Strickland, and Strickland has agreed to loan funds to the Committee. In order to obtain funds to loan to the Committee. Strickland has entered into a Loan Agreement (the "Bank Loan") with Colorado National Bank (the "Bank") dated June 26, 1996. Pursuant to the Bank Loan, Strickland has the right to borrow up to \$400,000 without security. In connection with the Bank Loan, Strickland has given the Bank a promissory note also dated June 26, 1996, by which he is obligated to repay the principal of any loans and to pay interest on outstanding principal balances at the variable rate of 1 percentage point above the Bank's Reference Rate. In addition, Strickland has paid a \$2,000 Loan Origination Fee in order to obtain the Bank Loan.
 - B. The parties anticipate that Strickland will loan the Committee up to \$400,000.
- C. The Committee believes that it will have ample funds to repay the loan, once Strickland wins the August, 1996 Primary Election.
- D. The parties intend that the Committee will repay Strickland all amounts borrowed by him, and that the Committee will pay, as interest, all amounts which Strickland is obligated to pay to the Bank on account of the Loan Agreement, specifically including interest and the Loan Origination Fee.

NOW. THEREFORE, in consideration of the mutual promises herein contained, the parties agree as follows:

- 1. <u>Borrowing.</u> Strickland hereby commits to loan to the Committee up to \$400,000 in principal, as and when such amounts are made available to him by the Bank, subject to the terms of this agreement and in accordance with the terms and conditions of the promissory note executed by the Committee on even date herewith and any extensions or renewals thereof.
- 2. Repayment. The Committee promises and agrees to repay the Loan and all other indebtedness of the Committee to Strickland with interest, which shall be the same rate of interest which Strickland is charged by Bank, as that may vary from time to time.
- 3. <u>Indemnity from other Bank charges</u>. In addition to payments of interest, the Committee shall indemnify Strickland from and against any other charges of any kind whatsoever imposed by the Bank on account of the Bank Loan, including the Loan Origination Fee and any default charges, default interest or other charge incident to and arising from the Bank Loan. Said amounts shall be paid on demand by the Committee to Strickland.
- 4. <u>Performance of Strickland's affirmative covenants.</u> The Committee will perform the Affirmative Covenants of sub-paragraphs 4(a), 4(b) and 4(d) of the Loan Agreement.
- 5. Events of default. Upon the occurrence of any of the following events. Strickland may, at his option and without notice of any kind whatsoever, suspend or terminate future advances on any line of credit to Borrower and/or declare the principal of and interest on the Note of the Committee and all Indebtedness of the Committee then remaining unpaid to be immediately due and payable, all without demand, presentment or other kind of notice of any kind, which are hereby expressly waived:

- a. Nonpayment of any principal or interest on its indebtedness to Strickland or liability to others when and as the same shall have come due and payable, whether at maturity, by acceleration or otherwise.
- b. Failure to promptly perform and observe the covenants, terms, and conditions hereof, or of any agreement or writing executed in connection herewith or if any statement, warranty or representation made herein or in any agreement, application or writing made or executed and delivered to Strickland in connection herewith is or proves to be untrue or misleading in any material respect.
- c. The Committee's adjudication as a bankrupt, or, if it makes any general assignment for the benefit of creditors, or the institution by of against it of any type of insolvency or winding up of its affairs, or the appointment of a receiver or trustee for the Committee or for any of its assets, or the approval of a properly filed petition for its reorganization of any petition by the Committee for an arrangement under the Bankruptcy Act or other similar act;
- d. If Strickland in good faith believes that the prospect of prompt payment if the indebtedness in full as and when due or the full performance of the Committee's indebtedness by the Committee is impaired.
- 5. <u>Construction</u>. It is the intent of the parties that the obligations of the Committee to Strickland be construed in the same manner as Strickland's obligations to the Bank are construed. Proof of a particular construction by the parties to the Bank Loan shall be conclusive on the parties hereto.
