In September 2025, after receiving notice from EagleBank that the AFC PAC bank account had been overdrawn, the AFC PAC Treasurer reviewed the account activity and determined that there had been fraudulent activity consisting of a \$2,200 cashed check and a \$297.83 debit charge. The Treasurer contacted the bank to report the fraudulent transactions by an unknown party. The unknown party attempted to cash additional fraudulent checks, but these were denied by the bank. The two fraudulent transactions, totaling \$2,497.83, are disclosed on Schedule B. EagleBank notified the bank where the unknown party cashed the check that the check was fraudulent. EagleBank noted to AFC PAC that the fraudulent checks were in the correct sequential order following the last genuine check, suggesting there may have been either improper disposal of checks or checks stolen or photographed from the PAC checkbook.

AFC PAC recovered all the funds from the fraudulent activity; these receipts are reported in Schedule A. AFC PAC has since evaluated its internal controls and implemented new safeguards to prevent future fraudulent activity, including opening a new bank account with EagleBank and enrolling in a positive pay system which will flag and require verification for any transactions that have not been pre-authorized by the PAC.
