Dear Mr. White:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule A of your reports disclose individuals with multiple contributions from different dealerships which are incorrectly reported. All contributions from a single individual, regardless of the number of different dealerships, should be aggregated together towards the individual's aggregate year-to-date total (see attached examples). Further, contributions received aggregating over \$200 per individual for the calendar year should be reported on Line 11(a)(i) and itemized on Schedule A.

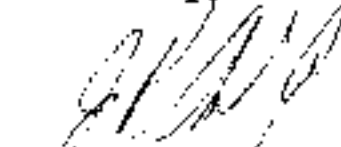
-For your information, all contributions received that aggregate \$200 or less per individual for the calendar year should be reported on Line 11(a)(ii). Contributions received aggregating over \$200 per individual for the calendar year should be reported on Line 11(a)(i) and itemized on Schedule A.

-Schedule A supporting Line 11(a)(ii) of the Detailed Summary Page discloses refunds of contributions to individuals/persons during the reporting period (see attached examples). Refunds to individuals persons, that were previously itemized on Schedule A, should be itemized on Schedule B supporting Line 28(a), Refunds of Contributions to Individuals/Persons, not as negative entries on Schedule A supporting Line 11 for contributions.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this
