In closing, thanks for your patience and that of my new analyst, Seth Kaye related to my termination report and filing amendments related to my Florida Campaign.

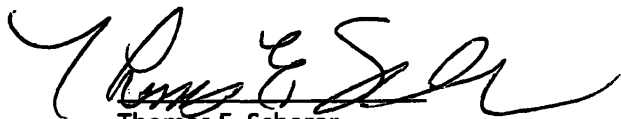
