Pursuant to the FEC's holdings in Advisory Opinions 2010-16 (EmblemHealth), 2004-42 (Pharmavite) and 2003-28 (Horizon Lines), Vantage Oncology LLC PAC Corporation (Vantage PAC Corporation) has listed McKesson Corporation as the connected organization because Vantage Oncology LLC, a disregarded entity for tax purposes, is wholly owned by McKesson Corporation. The FEC has permitted a disregarded entity wholly owned by a corporation to administer a separate segregated fund (SSF) because such a corporate structure "warrant[s] special consideration" in light of the disregarded entity's inability otherwise to either make contributions or administer an SSF. FEC Adv. Op. 2010-16 (EmblemHealth). In addition, the FEC has allowed an SSF to be named after an LLC that is wholly owned by the corporate entity serving as the SSF's connected organization because it "will provide the public with a more accurate understanding of the PAC's funding and purpose," as is the case here. FEC Adv. Op. 2004-42 (Pharmavite). Since Vantage Oncology LLC is not treated as a corporation for tax purposes, it may not be listed as the connected organization.
