

Why Dr. Fisher for Congress

The antibiotic *reexamination* spending needs making clear, than redoubling savings to programs such as Social Security, which are *concentrated* and safety net, presented not only to the elderly but to all citizens. This also requires that we cut the fat with the burden not disproportionately born by those making \$10,000.
