
I am writing to you in my capacity as Treasurer of the Democratic Party of Illinois ("DPI"), and in reference to the DPI's July 15, 1998 Quarterly Report which we are submitting herewith. In particular, I would like to direct your attention to the attached Memorandum, dated July 14, 1998, which was prepared by the accounting firm of Pandolfi, Topolski, Weiss & Co., Ltd. (the "Pandolfi" firm). That Memorandum indicates that the amount reported by the DPI on its December 31, 1997 Year End Report is different than the amount which appears to have been in the DPI's federal accounts as of that date.

By way of background, on April 3, 1998, a new chairman of the DPI was elected and accordingly a new administration was formed to oversee the DPI's operations. The Pandolfi firm was retained by the DPI in May of 1998 to conduct an audit of the DPI's accounts. Following a preliminary analysis of the DPI's federal accounts, we received the July 14, 1998 Memorandum that is referenced above.

Due to time constraints, we have been unable to determine the reason for the difference. However, it is our intention to comply fully with the laws and regulations governing the filing of campaign disclosure reports with the Federal Election Commission. Please contact me if you have any questions.
