Dear Sir or Madam:

The referenced Political Action Committee has twice been admonished that its quarterly reports were filed on obsolete FEC Form 3X forms. A response to the most recent notice of using an obsolete form, for the First Quarter, 2006 report, is forthcoming.

This letter serves to advise you that the enclosed quarterly report uses FEC Form 3X showing a revision date of 02/2003, which is the most current electronic version of the form available to us from your Commission. We have been directed to download from the FEC website the FEC data file containing most recent form available, which admittedly bears a revision date of 12/2004. However, when Form 3X is printed using the FEC software, the form that is produced bears a revision date of 02/2003. Accordingly we believe we are using the most currently available version of Form 3X. In fact, there is no material difference between the two versions of the Form.

This apparent problem was conveyed to Ms. Laura Sinram in the FEC's Reports Analysis Division on July 13, 2006, by Ms. Jacquelyn Ganskopp in this office. Ms. Sinram stated that a review will follow, and that we will be advised of any findings. Until that occurs, I ask that the enclosed Second Quarter report, completed on the 02/2003 version of the Form, be accepted without qualification.
