Since forming as a financial entity less than a year ago, the organization has affirmed its goals and recognizes a needed change to its reporting requirements and status.

The predominant financial function of our group is the annual planning, funding, and execution of our summit for high school leaders in Washington D.C. each summer. As the High School Democrats of America does not contribute to campaigns or fund any electioneering communications or efforts, we do not function as a Political Action Committee.

As such, we will be terminating our reporting requirements with the Federal Election Commission. We will now properly report to the Internal Revenue Service as a 527 group.

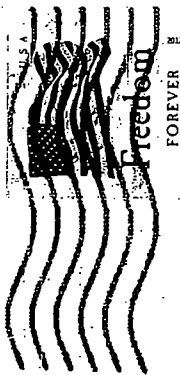

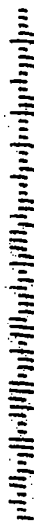
