Dear Mr. Francis:

This letter responds to your correspondence of September 29, 1999, and confirms our telephone conversation of this morning. San Diego Gas and Electric Company Citizens for Good Government is a corporate-sponsored separate segregated fund. In 1998, San Diego Gas and Electric Company's parent corporation, Enova, merged with Pacific Enterprises. At the time of merger, Pacific Enterprises sponsored a separate segregated fund under its name.


We contacted the Federal Election Commission staff to determine the best and most expedient means of combining the two SSFs. Since the Pacific Enterprises SSF was much larger than the San Diego Gas and Electric SSF, we were advised that the easiest procedure was to merge the latter into the former, advise members of the disappearing SSF of the change and allow them to withdraw from membership, and to change the name to reflect the new sponsoring entity. We followed this procedure; however, we did not realize that we also needed to file an amended Statement of Organization prior to dissolving the San Diego Gas and Electric SSF.
