This letter is prompted by the Commission's preliminary review of your Statement of Organization. The review raised questions concerning certain information contained in the Statement. An itemization follows:

-Please clarify your relationship, if any, with the Hellenic American Political Action Committee, Inc. Your committee has identified itself as a separate segregated fund with this entity as its connected organization. However, a connected organization according to 11 CFR § 100.6 is any organization which is not a political committee but which directly or indirectly establishes, administers, or financially supports a political committee. Furthermore, a connected organization may be a corporation, labor organization, membership organization, cooperative or trade association. If your committee is not a separate segregated fund, an amended Statement of Organization should be submitted to indicate the appropriate type of committee on Line 5(f) and box 6 should indicate whether any other entity is affiliated with your political action committee.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
