It will serve as an organization that is unincorporated and not affiliated with any other committee, organization, or business entity. It will be established as an Independent expenditure-only political committee, commonly referred to as a Super PAC. FEC regulations require establishment of a bank account prior to submission of FEC Form 1: Statement of Organization. This committee intends to make independent expenditures, and consistent with the U.S Court of Appeals for the District of Columbia Circuit decision in SpeechNow v. FEC, it therefore intends to raise funds in unlimited amounts. This committee will not make any contributions or expenditures to any candidate, issue, or ballot measure that are State or Local in Nature.
