
In response to your letter of inquiry dated February 14, 2001, the American Meat Institute Political Action Committee (AMI-PAC) has reviewed and amended its 2000 October Quarterly Report.

The amendments include:

1. Adjustment of an itemized disbursement of \$2,000 to the Walsh for Congress Committee as listed on line number 23, Page 4 of 4 now amended to show that the disbursement was for the campaign's primary election.
2. Adjustment of Itemized receipts on line 11a(i), "Aggregate-Year-To-Date", to accurately reflect and incorporate the individual's contribution amount.
3. Adjustment of Itemized Disbursement on line number 23 to include "House", "Senate" or "President" when appropriate in the "Purpose of Disbursement" field.
4. Adjustment of Itemized Disbursement to the City Club on page 2 of 4 of previously submitted report to include the City Club's address.


