This letter is in response to your letter dated May 19, 1998 and the letter from John D. Gibson dated June 11, 1998. Both letters are in reference to this committee's Year-End Report (7/1/97-12/31/97).

-- Please note on the amended Detailed Summary Page we have reported the contribution to another political committee on Line 21.

--The beginning cash balance used for the original 1997 Year End Report, \$23,018.91, is the same figure that appears on our committee's amended 1997 Mid Year Report dated November 14, 1997. The beginning cash balance used on the attached amendment for this period is a new figure from the amended 1997 Mid Year Report which also is enclosed.

-- With this letter we are amending line 11c to reflect \$2000 from Dealers Election Action Committee originally recorded as a Primary 98 contribution. The contribution was designated for Special Election 97 debt reduction.

--Enclosed find amended Schedules A and D including line 11ai, 11c and line 17, 20a.

The Schedule A, line 11ai amendment shows contributions not available for recording when the original report was filed. Copies of redesignation, reallocation and refund documentation supporting our correction of all excessive contributions is included. Please also note (1) seemingly excessive YTD figures which appear on the original report and this amendment reflect contributions received for both the New Mexico District 3 House of Representatives Special Election cycle March 1, 1997 through May 13, 1997 and the 1998 Primary cycle. Detailed Itemized Receipts pages is not the same as the total which appears on the Detailed Summary Page. This difference represents software-programming problems we are experiencing for reporting reallocations to spouse, and, redesignations which overlap reporting periods. We are currently in communication with the developers of the Frontrunner software program (Capitol Micro Systems) to resolve this problem. A copy of a recent letter appears following the documentation for this detailed report.

Contributors whose excessive contributions have been corrected include Phelps Anderson, Roy T. Stryker, Mrs. A. N. Spencer (Mrs. Spencer does not use a first name for her check signature. To distinguish contributions from Mrs. and Mr., we have hand entered "Mrs." where contributions are hers), Martin Goodwin, Dan Wade, Thomas K. Reed, Sherilyn DeSantis, Dusty Bolton, Joel Dahlby, Stanley Hubbard, Martin Howser and Don Tripp. Reallocation/redesignation documentation also appears.

Amendment to Schedule D, line 17 Debts and Obligations reflects payment on debt owed Bill Redmond and unpaid debt owing the committee by a former consultant.

Amendment to line 17 reflects in kind disbursements on 9/17 and 9/30 to the National Republican Congressional Committee not available to us at the time the original report was filed and \$300 paid in July to Zenitram Industries not itemized on the original report.

Also enclosed please find amended pages 1 and 2 plus affected detailed schedules and documentation for the periods identified below. Each amendment reflects information found during internal systematic review of all financial records. Schedules A line 11ai, 11b and 11c, 13a, Schedule B line 17, 19a and Schedule D are affected.




