


We made these refunds when we discovered and verified that these contributions came from incorporated farms. We have stopped the contributions from these farms.

That form (copy enclosed), states in bold print "My farm is not incorporated and I agree to notify C-TAPE should I change it to a corporation, because corporation contributions are illegal".

Our field personnel are also instructed to not sign up any incorporated farms.


