There has been an error, in either entry or with the software that has resulted in \$50 donations being reported as \$250 donations. This occurred in four separate quarters, and resulted in an overstatement of funds of \$800. However an additional error has been detected. In this case \$249 in two separate donations was not reported in Oct. 2006. The two sets of errors resulted in an overstatement of funds of \$551. Using guidance from FEC staff and to reconcile actual receipts and expenditures, an amount of \$551 has been designated to account adjustment in line 21b.
