ITEM 1 - APPARENT EXCESSIVE CONTRIBUTIONS FROM INDIVIDUALS AND COMMITTEES
THE COMMITTEE IS ACTIVELY ENGAGED WITH EACH CONTRIBUTOR REFERENCED IN THE ATTACHMENT TO THE RFAI, INCLUDING DOUGLAS ALLRED, CHARLES LONG, AND ROAD TO FREEDOM CAMPAIGN COMMITTEE, TO CURE THE APPARENT EXCESSIVE PORTIONS OF THE CONTRIBUTIONS IN QUESTION. THE COMMITTEE INTENDS TO RESOLVE EACH ITEM THROUGH THE APPROPRIATE COMBINATION OF REFUND, REDESIGNATION, OR REATTRIBUTION CONSISTENT WITH 11 CFR 110.1. ANY RESULTING REFUNDS, REDESIGNATIONS, OR REATTRIBUTIONS WILL BE DISCLOSED ON THE NEXT REGULARLY SCHEDULED REPORT, OR SOONER BY AMENDMENT SHOULD THE CURATIVE ACTION AND SUPPORTING DOCUMENTATION BE COMPLETED IN ADVANCE OF THE NEXT FILING DEADLINE.

ITEM 2 - CONTRIBUTION FROM TARA PAC
THE COMMITTEE IS IN THE PROCESS OF CONFIRMING WITH TARA PAC THAT THE CONTRIBUTION DATED 12/31/2025 WAS MADE FROM FUNDS PERMISSIBLE UNDER THE FEDERAL ELECTION CAMPAIGN ACT, CONSISTENT WITH 11 CFR 102.5(B). UPON RECEIPT OF THAT CONFIRMATION, THE COMMITTEE WILL AMEND THE YEAR-END REPORT TO REFLECT THE APPROPRIATE CLARIFYING INFORMATION. IN THE EVENT THE CONTRIBUTION IS DETERMINED TO BE IMPERMISSIBLE, THE COMMITTEE WILL ISSUE A TIMELY REFUND IN ACCORDANCE WITH 11 CFR 103.3(B) AND REPORT THE REFUND ON THE APPLICABLE SCHEDULE B.

THE COMMITTEE ACKNOWLEDGES THE ADVISORY REGARDING THE INCORRECT FEC COMMITTEE ID NUMBERS LISTED FOR NRA VICTORY FUND, INC. AND SEAL PAC USA. THE CORRECT IDENTIFICATION NUMBERS HAVE BEEN VERIFIED AND WILL BE REFLECTED IN AN AMENDED YEAR-END REPORT.

CORRECTIVE SYSTEM IMPROVEMENTS
IN ADDITION TO THE CURATIVE ACTIONS DESCRIBED ABOVE, THE COMMITTEE HAS CORRECTED THE CONTRIBUTION ALERT THRESHOLDS WITHIN THE TECHNOLOGY PLATFORM USED TO MANAGE THE CAMPAIGN'S DONATIONS. THE UPDATED CONFIGURATION IS DESIGNED TO FLAG POTENTIALLY EXCESSIVE OR OTHERWISE ISSUE-FLAGGED CONTRIBUTIONS ON A MORE TIMELY BASIS SO THAT CURATIVE STEPS CAN BE INITIATED WITHIN THE REGULATORY WINDOWS PROVIDED UNDER 11 CFR 110.1 AND 11 CFR 103.3.
