This letter is submitted by the undersigned counsel on behalf of Freedom Path (FEC ID C90012832) in response to your later dated June 4, 2012, referencing Freedom Path's April Quarterly Report. Freedom Path's report is in compliance with Federal Election Commission regulations and no amendments are required.

Your request asserts that "[e]ach contributor who made a donation in excess of \$200 used to fund the independent expenditure(s) must be itemized on Schedule 5-A" and refers to 11 CFR §§ 109.10(e)(1)(vi) and 114.10(f). The cited regulations state, in pertinent part, that the report must include "[t]he identification of each person who made a contribution in excess of \$200 to the person filing such report, which contribution was made for the purpose of furthering the reported independent expenditure" (emphasis added). 11 C.F.R. § 109.10(e)(1)(vi). We note that the regulation requires reporting of contributions stemming from the intent of the donor, not the ultimate use of the contribution by the recipient.

Freedom Path has not received any contributions for the purpose of furthering the reported independent expenditures and does not solicit contributions for any such purpose. Furthermore, Freedom Path is not a Qualified Nonprofit Corporation; therefore, 11 C.F.R. § 114.10(f) is inapplicable. Accordingly, the regulations cited do not require Freedom Path to disclose any contributors and no amendment to the referenced report is required.

Freedom Path is aware of the reporting obligations under 11 CFR § 109.10. If, in the future, Freedom Path receives a contribution for the purpose of furthering an independent expenditure, then it will be properly reported to the Federal Election Commission on Form 5.

Failure to comply with the provisions of the Act may result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
