Brian Jones FEC Analyst - This is in response to the RFAI dated 4/29/14. Regarding the Oxford Communications credits and debits on the schedule D, the Oxford bills reported as debt in July 13 were reported in error. In an attempt to be fully compliant with federal elections law the committee reported debt which in fact were invoices for non-federal activity. The committee paid those non-federal expenses with non-federal income and tried to remove the debts by entering the negative entries. The committee will be amending the reports to remove that debt which was for non-federal activity. The report has been amended to clarify that the fundraising consultants were not employees of the Ohio Republican Party. It has also been amended to clarify that the insurance premiums reported were for employees that were not spending more than 25% of their time on federal election activity. The report has been amended to include a bank fee which was inadvertently left off.
