Dear Jack Baisden:

This letter is in response to your letter dated April 14, 2016 concerning the Year-End Report of the Committee filed on January 29, 2016. Your letter requested that the Committee provide state-specific detail on an independent expenditure by the Committee. This issue was previously the subject of a prior letter making an inquiry with respect to the Independent Expenditure Report on which this independent expenditure was reported (FEC-1037523 dated December 28, 2015). That Independent Expenditure Report was amended on March 15, 2016 (FEC-1055367). Because the Year-End Report was filed prior to the March 15, 2016 amendment of the Independent Expenditure Report, the Year-End Report did not contain the amendment made to this particular filing. The Committee has amended its Year-End Report to provide the same detail on the Year-End Report as was reported on the amended Independent Expenditure Report.

If further clarification or any additional information are needed to resolve this issue, please let us know.

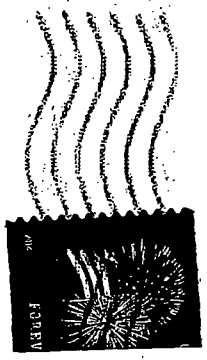

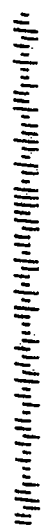
