NOTE 1 - KEZIOS PROPERTIES

The Committee's written lease agreement with Kezios Properties expired January 31, 1993. The Committee continued to occupy various locations within the property through May 1996 while attempting to negotiate the fair market rental value for those spaces. Those negotiations terminated and the Committee filed litigation seeking a declaration of its rights and obligations pertaining to its occupancy of those spaces. That litigation also seeks an accounting of payments made and the aggregate amount outstanding for those spaces. Kezios Properties filed a counterclaim containing several counts relating to the Committee's occupancy of various locations within the property. The counterclaim alleges purported breaches of various asserted leases and it seeks damages totaling \$174,195.08, plus interest and cost. Thereafter, Kezios Properties filed a Motion for Summary Judgment on Count I of its counterclaim relating to a portion of the property occupied by the Committee for which a formal written lease existed. The Motion for Summary Judgment was opposed by the Committee. The court granted Summary Judgment on Count I, resulting in the payment by the Committee of \$56,020.38 to Kezios Properties. The Committee continues to seek an accounting regarding those locations within the property for which, the Committee asserts, no formal written lease exists. Thus, the Committee vigorously opposes the remaining counts of the Counterclaim.

NOTE 2 - BONSAI ENGINEERING CONSULTANTS

The Committee disputes the amount totaling \$41,805.00. The vendor has not actively pursued its claim since approximately November 1995. The Committee filed litigation challenging the claim of this vendor and seeking damages against this vendor in excess of the amount of the claim of this vendor.
