This notice is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Your report discloses entries from political committees with the purposes of "Campaign returned original contribution check to UTI PAC" on Schedule B supporting Line 28(b) of the Detailed Summary Page. If the check written by your committee was not cashed and was made to a Federal political committee, you should itemize the voided check on Schedule B supporting Line 23 as a negative entry. Line 16 should be used if the recipient Federal political committee cashed your check and wrote a refund on its account.

If the checks written by your committee were not cashed and was made to a non-federal political committee, you should itemize the voided checks on Schedule B supporting Line 29 as a negative entry. Line 17 should be used if the recipient non-federal committee cashed your check and wrote a refund on its account. Please amend your report to correct this discrepancy or provide clarification regarding this transaction.
