Please note previously disclosed best efforts memo text. With respect to payroll, payroll taxes, and other payroll or employee benefit-related expenses the party adheres to 11 CFR 300.33, and also follows the commissions revision of the rules as adopted on December 1, 2005. Specifically, the party pays for these costs with 100 percent federal funds when the employee spends more than 25 percent of his or her time in a pay period on federal election activity FEA or activity in connection with a federal election. These expenditures are reported on Schedule B for Line 30b. Alternatively, when an employee does not meet the 25 percent threshold, the party allocates the costs as an overhead/administrative expense and reports the disbursements on Schedule H4. Additionally employees payroll and reimbursed expenses are paid according to the activities they participate in, whether it is a fully federal or FEA activity, or an administrative or otherwise permissible allocated activity, as indicated by the documentation provided by the employee. The Republican Party of Arizona LLC uses a tickler system to track transfers of non-federal funds for allocated administrative expenditures to comply with 11 CFR 106.6(e)(2) and 106.7(f)(2) of the election code, in making timely transfers no more than 10 days before or 60 days after the payment to vendors of federal funds. The Republican Party of Arizona LLC received contributions in excess of federal contribution limits from various donors. With the permission of the donors, the excess was transferred to the non-federal account and is indicated in the reporting description. For all expenses requiring memos (payroll, credit card transactions, and reimbursements), all memos over the \$200 aggregate itemization threshold have been reported. Any memos that do not reach the \$200 aggregate itemization threshold are not itemized on this report. All payroll memos are dated the same as the associated hard transaction. Not all payroll memos are allocated expenses, and so not all memos appear on Schedule H4. All expenses reported as Administrative expenses on Schedule H4 are not fundraising expenses and have been reported correctly. RPA reviews all contributions for impermissibility and excessiveness and takes appropriate action when necessary. The committee typically indicates to all donors that excessive contributions or inadvertent deposits of impermissible donations will be transferred to the appropriate accounts as per the disclaimer provided. All credit card contributions reported as negative contributions on Line 11 were disputed by the donor and processed as a chargeback. All returned credit card contributions processed as refunds are reported as refunds on Line 28. Records may have been combined or spouses separated. ECTD reflected in this report are correct. Please note: all transfers reported from other party committees (RNC, NRCC, NRSC) were not earmarked by the donor for any particular purpose or candidate or to specifically fund exempt activities. Due to a software limitation, all JFC memo contributions received after 12/31/2024 & attributed to the 2024 annual limits are showing a \$0 year to date total.
