I am writing in response to your letter dated June 6, 2008 with regard to my client, the Walt Disney Productions Employees PAC ("Disney PAC"). Per your request, attached please find a copy of the letter from Disney PAC to Team Sununu requesting a refund of \$500. Once Disney PAC receives the refund check, it will be reported on Schedule A supporting Line 16 of the report covering the period during which the refund was received.

In addition, Disney PAC's April monthly report was amended on June 26, 2008 to indicate that the contribution to Steve Chabot for Congress dated March 11, 2008 was intended for Representative Chabot's general election and the March 26, 2008 contribution to Senator Sununu was designated for the general election and is now reported as such. In your conversation with Carrie Hoback, you stated that submitting an amended April monthly for these two contributions would satisfy your request.

Dear Mr. Collins:

I am writing on behalf of the Walt Disney Productions Employees PAC ("Disney PAC") regarding a contribution to Senator Sununu's 2008 primary election dated December 12, 2007 in the amount of \$1,000. The contribution was undesignated and was reported by Disney PAC as a contribution to the primary. It should have been noted that the \$1,000 contribution in December was designated as \$500 to the 2008 primary election and \$500 to the 2008 general election.

Because the contribution was undesignated, and a request for redesignation was not made within 60 days, we are required to ask for a refund of \$500 to remedy any excessive contribution to Senator Sununu's 2008 primary election.
