This letter is to inform you that as of November 25, 1997, the Commission has not received your response to our request for additional information, dated October 29, 1997. This notice requests information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to this request (copy enclosed).

The Commission notes the receipt of your Amended August, September and October Monthly Reports received November 12, 1997 which provided corrected Detailed Summary Pages for Lines 23 and 29 reflecting a \$12,125 contribution reattributed on the Amended July Monthly Report of July 23, 1997. You, however, did not clarify the change to the Detailed Summary Page, Lines 23 and 29, for the Amended July Monthly Report dated October 6, 1997.

If no response is received within fifteen (15) days from the date of this notice, the Commission may choose to initiate audit or legal enforcement action.
