#### NOTE 1 - SHEADS AND ASSOCIATES

The Committee understands the obligation to this vendor has been reduced through the rental of the Committee's direct mailing list, by the Committee's former direct mail consultant, Losser and Associates. The Committee previously requested an accounting of all direct mail rental activities from the former direct mail consultant, Losser and Associates, as well as from Sheads and Associates. Such accounting was not provided.

The Committee filed a formal complaint against Losser and Associates alleging, inter alia, breach of contract and unjust enrichment. A default judgment in favor of the Committee has been recently granted against Losser and Associates. The Court will determine the amount of damages to be assessed against Losser and Associates. Until the Committee verifies the actual amount by which the obligation to Sheads and Associates has been reduced as a direct result of the rental activities of Losser and Associates, the Committee continues to dispute the amount of the obligation owed to Sheads and Associates.

#### **NOTE 2 - KEZIO PROPERTIES**

The Committee's lease agreement expired January 31, 1993. The Committee continued to occupy various locations within the property through May 1996 while attempting to negotiate the fair market rental value for those spaces. Those negotiations have terminated and the Committee has filed litigation seeking a declaration of its rights and obligations pertaining to its occupancy of those spaces. That litigation also seeks an accounting of payments made and the aggregate amount outstanding for those spaces. Kezio Properties has filed a counter claim alleging a purported breach of lease with damages totaling \$174,195.08. The Committee vigorously opposes this vendor's counter claim.

#### **NOTE 3 - BONSAI ENGINEERING CONSULTANTS**

The Committee disputes the amount totaling \$41,805.00. The vendor has not actively pursued its claim since approximately November, 1995. The Committee filed litigation challenging the claim of this vendor and seeking damages against this vendor in excess of the amount of the claim of this vendor.

#### **NOTE 4 -EARL HOPEWELL**

On or about September 5, 1996, Earl Hopewell filed a complaint against the Committee and Senator Carol Moseley-Braun alleging, inter alia, breach of contract and seeking damages from the Committee in an amount in excess of \$170,000. Immediately thereafter, the Committee filed a separate action against Earl Hopewell, requesting, inter alia, that Mr. Hopewell provide an accounting to the Committee as to all amounts paid to the defendants. Subsequently, the two separate cases were consolidated in the Law Division of the Circuit Court of Cook County, Illinois. The Committee strongly disputes the amount Mr. Hopewell has alleged he is owed by the Committee. The Committee will continue to vigorously oppose Mr. Hopewell's claims and will actively pursue its causes of action against Mr. Hopewell.

#### NOTE 5 - DORSEY NORMAN AND ASSOCIATES

The Committee disputes the validity of this claim submitted to the Committee subsequent to the general election for an amount of \$8,099. The Committee further asserts that all activity by this vendor was consummated on an "pay-as-executed" basis.
