
Dear Chair Bauerly and Vice Chair Hunter,

The purpose of this letter is to notify the Federal Election Commission, pursuant to 11 C.F.R. § 110.3(c)(5)(i)(D), that I, Thaddeus G. McCotter, and my authorized committee, McCotter Congressional Committee, will no longer conduct campaign activities in connection with the 2012 primary and general elections for the U.S. House of Representatives, except in connection with the retirement of debts outstanding at the time of this letter.

McCotter Congressional Committee intends to make a transfer of funds, pursuant to 11 C.F.R. § 110.3(c)(5), to another principal campaign committee for use in connection with the 2012 Presidential election. At the time this transfer of funds is made, I will be seeking nomination and/or election to only one Federal office.


