The reports have been amended to clarify that they relate to a special and primary election, respectively.


Your letter regarding the 24 HOUR NOTIFICATION REPORT (08/05/2010 - 08/23/2010), RECEIVED 08/23/2010 states that this report does not disclose the correct office sought by the candidate named in the report. The report has been amended to clarify that the candidate sought Senate office.

Your letter regarding AMENDED 24 HOUR NOTIFICATION REPORT (09/30/2010 - 10/01/2010), RECEIVED 10/20/2010 states that the report may have been late because the report indicates that it relates to the Wisconsin primary election and disclosed expenses after the primary election date. The report should indicate that it relates to the general election; the candidate named in the report was unopposed in the primary election (see page at <http://gab.wi.gov/sites/default/files/2010%20Fall%20Primary%20summary%20post%20recount.pdf>). The report has been amended to clarify that it relates to the general election.

Your letter regarding AMENDED 24 HOUR NOTIFICATION REPORT (10/02/2010 - 10/14/2010), RECEIVED 10/29/2010 states that one entry of the report does not indicate whether the expenditure disclosed on the report supported or opposed the named candidate. The report has been amended to clarify that the expenditure opposed the candidate.
