The purpose of this amendment is to correct an error in our records which caused an attributed contribution between Manley Porter and Cindy Porter from being properly reported. Additionally, in further review of our report, we found there were two deposits that were reported and should not have been. The deposits were made on April 1, 2014 and April 7, 2014, however they contained contributions received by the campaign between March 28, 2013 and March 29, 2014. These contributions were properly recorded in the April Quarterly report and were unintentionally reported in the Pre-Primary report as well.

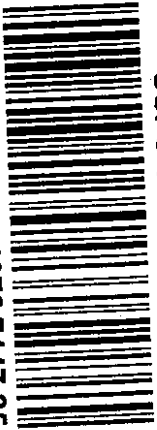

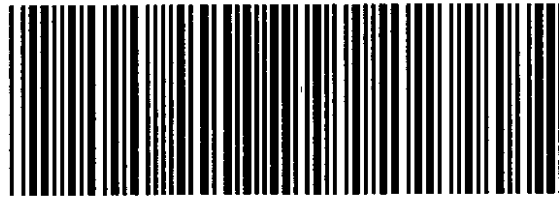

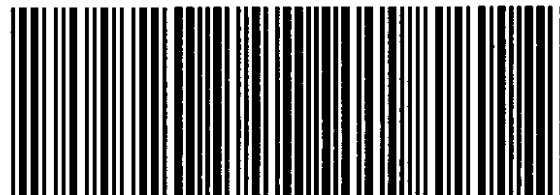
