This letter is in response to the Federal Election Commission's ("FEC") Request for Additional Information ("RAFI") dated May 10, 2013.

According to the RAFI, the U.S. Cuba Democracy Political Action Committee ("the Committee") made a contribution to RAFAEL EDWARD TED CRUZ ("the recipient") for the retirement of debts incurred by the 2012 Primary election campaign. However, it now appears that the recipient had insufficient debts to warrant such a contribution.

At the time of the contribution, the Committee was informed the recipient still had existing Primary election campaign debt. As such, the contribution was made on December 28, 2012 and promptly reported on the Committee's 2012 Year-End Report.

Thereafter, the contribution was fully refunded by the recipient on March 31, 2013. Attached is a copy of the refund check ("Attachment A").

In compliance with the FEC's rules and regulations, this refund will be promptly reported on Line 16 of the Detailed Summary Page and on Schedule A of the Committee's upcoming 2013 Semi-Annual Report, which covers the corresponding period of January 1, 2013 to June 30, 2013.
