Dear Mr. Furman,

This statement is in response to the Commission's letter to the Committee dated January 27, 2021, requesting additional information on two items related to the above-referenced report (the "Original Report").

With respect to the first request, as described in further detail below, all of the contributions identified in the Attachment to the Commission's letter have been appropriately reattributed, refunded/charged back, or returned to a joint fundraising committee ("JFC") in which the Committee participates for proper reallocation. The relevant information is or will be reflected on either, as appropriate, the Amended Report being filed by the Committee along with this submission or a subsequent Committee report. As to the second request, the Committee is working on providing the information and once able will do so promptly.

Additional information in response to first request:

-The October 4, 2020 contribution from Prayerie PAC identified in the Commission's letter was redesignated to the Committee's recount fund.

-The October 7, 2020 contribution from the Strengthening The American Republic (STAR) PAC identified in the Commission's letter was refunded.

-The Commission's letter also requests clarification on contributions from 1,112 individual contributors disclosed on the Original Report. With respect to those contributions:

-1,091 of the listed contributors' contributions were either refunded or charged back to the contributor's credit card.

-2 of the listed contributors' contributions were made by contributors who had contributed to the Committee but subsequently made additional contributions to either the Trump Victory (C00618389) or Trump Make America Great Again Committee (C00618371) JFCs, which distributed the contributions to the Committee. Any funds received through a JFC distribution that resulted in an excessive contribution have been returned to the JFC for reallocation among participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be disclosed by the relevant JFC on the appropriate report.

-19 of the listed contributors' contributions were in part (i) redesignated to another election and (ii) either (a) refunded or (b) returned to the JFC that transferred the contributions to the Committee to be reallocated by that JFC among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The refunds or reallocations will be disclosed by the relevant committee on the appropriate report.
