This transaction is in reference to the RFAI Notice dated February 24, 2019 regarding the 30 Day Post-General Report. During this period, on October 24, 2018 the committee contributed \$5,000 to the Debbie Wasserman Schultz Campaign. Prior to this, back on May 29, 2018, the committee made a \$10,000 contribution to the Debbie Wasserman Schultz Campaign and allocated \$5,000 to the Primary Election Cycle and \$5,000 to the General Election Cycle, and reported this in the FEC reports. In researching the excessive contribution issue raised by the RFAI, it became apparent that the \$10,000 check for the two \$5,000 contributions to the Debbie Wasserman Schultz Campaign was prepared, reported on the FEC reports, but never sent. Accordingly, this check is being VOIDED and the reports are being amended to properly reflect this.
