I am writing to inform you that the Political Action Committee known as BAYPAC, I.D. NUMBER C00155713, located at Box 271082, Tampa, Florida 33688 has been discontinued and will no longer operate.

I received a letter dated June 17 2016 from Paul Stoetzer of the Reports Analysis Division indicating that the last report I filed contained numerous mistakes and that the report needed to be corrected and re filed.

Unfortunately, I am unable to do that. When I filed the original report, I enclosed a letter indicating that in 2015, we experienced a flood in our house which damaged and/or destroyed all of my records and many of my keepers. Therefore, I was attempting to file the report from memory, with no back-up to refer to or previous reports to reference.

I am 79 years old and do all the fundraising and administrative work for BAYPAC myself,

This letter is prompted by the Commission's preliminary review of the report referenced above. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
