On October 1, 2013 I completed FEC Form 2, the *Statement of Candidacy*, and forwarded it to your offices by FedEx for hand delivery on October 2, 2013, addressed to the Secretary of the Senate, 232 Hart Senate Office Building, Washington, DC 20510-7116. 



