The Committee apologizes for the delayed response to your initial request for additional information. The request was received by the Committee just after a new Financial Assistant had joined the Committee staff and thus the letter was not reviewed by the Committee until just recently. In response to the information requested in the letter, the Committee is prepared to outline in detail the process whereby contributor information is collected. To comply with Commission regulations which require a committee to disclose the identification of all individuals who contribute in excess of \$200 in a calendar year, the Committee includes clear requests for all necessary contributor information upon original solicitation. To begin with, the information requested is noted as required by Federal law. In addition the Committee asks that the contributor provide the following information: full name, mailing address, occupation and name of employer. In the event that some or all of the above information requested is not initially provided, the Committee undertakes measures to ensure that 'best efforts' are made to obtain the information. In this regard, the Committee sends a follow-up letter to the contributor requesting the missing information. Original letters to gather information were sent in July for those contributors whose employer or occupation fields were labeled as 'information requested.' Upon receipt of further contributor information, the Committee will then amend the Report for which the information was requested to include the missing information. This response will precede an amendment to the Mid-Year Report to reflect updated contributor information that the Committee has since received. In addition, the Committee will amend the contributor 'Self-Consultant' description previously provided to a more specific and detailed description. Thank you in advance for your consideration.
