Dear Ms. Kang:

Enclosed please find the 3rd quarter report for the United Defense L.P. Employees Political Action Committee. Also enclosed are amended reports for the 1st and 2nd quarters, precipitated by software calculation errors discovered while compiling the 3rd quarter report.

As you recommended to PAC Administrator Patrice Taylor today by telephone, I am including further explanation of the calculations for the 3rd quarter Schedule A filing. United Defense L.P. changed payroll companies in July 2000, which changed the timing and frequency of payroll information provided for input to our PAC software. The new payroll system forwards payroll information on a weekly basis, ensuring that all information is received before the month closes. The former payroll system, in effect since the formation of the PAC in 1997, forwarded payroll receipts information within the first week of the *following* month. Therefore, for the 3rd quarter report *only*, there will be two payroll deductions recorded in the month of July, in addition to the employee receipts received in August and September. This one-time occurrence makes the Schedule A right-hand column total four months of payroll deductions rather than just three.
