Nomorecpd is the name with which I am generally identified in the community in the context of my campaign for the presidency. In New York, my state of permanent residence, candidates are entitled by law to appear on the ballot as they are generally known in their communities. I recognise that this name is unusual; however, I make a sincere request that my name be allowed, as my name is integral to my campaign. I do not intend to campaign under any other name, with the possible exception of an unabbreviated form of Nomorecpd which is highly cumbersome. I note that there is ample precedent for accepting unusual names for presidential candidates and their committees from this election cycle alone: see Limberbutt McCubbins and The Committee for the Installation of Limberbutt (P60007366), Jeb Bush and Jeb 2016, Inc (legal name John Ellis Bush; P60008059), Sydneys Voluptuous Buttocks and The Syd Buttocks Committee (P60005931), no fewer than five variations on Deez Nuts (P60009198, P60011426, P60011350, P60013018, P60013737) & cetera. I therefore believe that, to the best of my knowledge, neither my stated name nor the name of my designated principal campaign committee is in any way false or erroneous, nor do I believe that they are grounds for denial of acceptance of this Form 2 and my forthcoming Form 1. Thank you. Respectfully submitted, Nomorecpd Name at birth and current legal name: Andrew Re Martin Postscript: I am in no way related to, nor had I heard of prior to today, vexatious litigant and perennial candidate Anthony Robert Martin-Trigona, commonly known as Andy Martin, who has apparently also filed a Form 2 as a presidential candidate (P60008943).
