Please find enclosed the Mid-Year FEC Report Republicans for Choice, PAC is required to file today. Since we have changed our payable procedures since our meeting on May 21, 1997, this report is more involved than our standard report. For that reason I wanted to take a minute to further explain a few issues you will encounter in your review of this report.

1. As you and I have discussed in the past, Republicans for Choice, PAC often provides benefit to candidates through in-kind expenses. On this report, the in-kind expenses are related to direct mail expenses which aided the particular candidates designated on Schedule B.
2. Since we changed our payable procedures on 5/22/97 you will see our disbursements reported in two different ways.
 - A. 1/1/97 - 5/21/97 - Reporting federal disbursements on Schedule B. The state account payments during this time period totaled \$148,302.92.
 - B. 5/22/97 - 6/30/97 - Using Schedule H4
3. Due to this change-in procedure it was necessary for us to include all of the state expenses on line 18 in order to balance. Only \$18,282.63 was actually transferred from our state account to our federal account. The remainder of the funds on line 18 (\$148,203.92) were direct payments from the state accounts.

I hope these explanations make our intentions a little easier to decipher. As always, should you have any questions please feel free to contact me.
