Please accept this letter as notification that as an unsuccessful 2004 candidate for Congress in Maine's Second District, I have made a decision to close out my account with the FEC and withdraw the remaining cash balance in our bank account of \$497.68. This final withdrawal will be used to offset the \$6,000.00 loan that I made to the Hamel for Congress campaign, thus leaving a loan balance of \$5,502.32. I have made a decision to write-off the remaining loan balance and will not pursue collection from the Hamel for Congress campaign.
