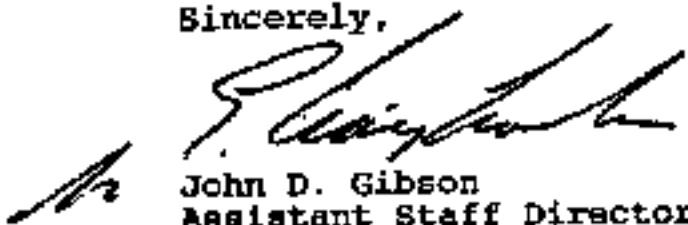
Dear Mr. Loafman:

-It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 1995-1996 election cycle and fill in the appropriate dates on Line 5 of the Summary Page.
