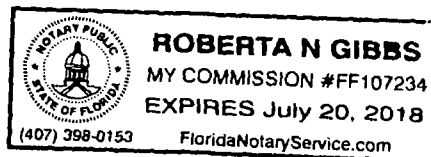

For the Letter rate, the UPS Express Envelope must weigh 8 oz. or less. Express Envelopes weighing more than 8 oz. will be billed by weight.

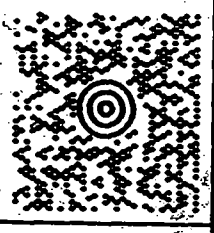

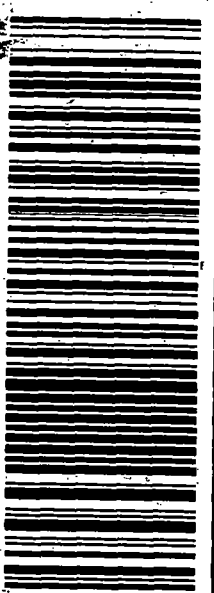
