Dear Mr. Bennett,

This letter is in response to the Commission’s request for additional information regarding the following:

- 1)The Commission inquired about independent expenditures on Schedule E that may not have been filed or may have been untimely filed on a required 48-Hour report for independent expenditures.
- a.For the independent expenditures listed in your letter as “Missing 48 Hour Report”, the Committee has identified each 48H report filing disclosing each independent expenditure and have listed the Image Numbers of the 48H and the date the 48H report was filed per transaction below.
- i.In the comma-separated list in Attachment A, we’ve listed the name of the payee, the dissemination date, the amount, candidate, election, Image number of the 48H report that discloses the same IE and the date the 48H report was filed.
- b.The Committee acknowledges receipt of a late invoice for an independent expenditure supporting Angela Alsobrooks and subsequently was late on disclosing the independent expenditures reaching threshold. The Committee has taken steps to clarify reporting requirements to independent expenditure vendors.
- 2)The Commission also inquired about independent expenditures disclosed on 48-Hour reports but may have been missing on Schedule E.
- a.The Committee has identified the Image numbers of each page on the October Quarterly report that discloses the independent expenditures in question.
- i.The independent expenditure paid to CASA In Action for \$2,742.80 on behalf of Angela Alsobrooks can be found on Image# 202410229710099341 of the October Quarterly Report.
- ii.The independent expenditure paid to Pendulum Creative Group LLC for \$3,049.67 on half of Angela Alsobrooks can be found on Image #202410229710099381 of the October Quarterly Report.
