The other day on the phone you mentioned to me that the FEC had not received FEC Form 2 from the Eric Serna campaign. I asked Mr. Serna's secretary to look through her records and she provided me with the enclosed. Apparently this was mailed to the FEC in early December, 1997.

I am also enclosing FEC Form 1 which was sent at the same time.

In a recent letter to you (or to the FEC) I indicated that we were approaching this as a new file, despite the fact that Mr. Serna was a candidate for the same office in a special election which was held in 1997. I do not know if the FEC wants to assign a new identification number to the present campaign. We have left that box on Form 2 blank. I should tell you that in our initial financial report to the FEC, filed about a week ago, I used the old number (for lack of a new one).
