To Whom it May Concern:

We wish to provide the following supplemental information for voided check transactions listed on our campaigns July Quarterly Report.

Dickinson Wright PLLC: Was not cashed by the vendor and was replaced by subsequent payments on 6/7/2021 and 7/22/2021.

Grand Valley Consulting, LLC: Was not cashed by the vendor and was replaced as a part of a payment made on 6/7/2020.

Jennifer Naedler Consulting: Both payments were not cashed by the vendor. One was replaced by a payment made on 9/3/2020. The other was determined to be an expense for Crenshaw Victory Committee, so the payment was voided and not re-issued by the campaign. It was later paid by Crenshaw Victory Committee to satisfy the balance with the vendor.

Walden & Associates: The voided payment was a duplicated expense, with two checks inadvertently written to this vendor on the same day. The vendor did not cash the second payment.

Akin Gump Strauss Hauer: This payment was voided after it was later discovered that the campaign had been billed twice. The vendor did not cash the second payment.

Athletes and Causes: No tickets were ever received by the campaign and the payment was never delivered to the vendor.

Maverick Campaigns, LLC: The voided payment represents an incorrectly billed amount. The campaign was re-invoiced and paid the vendor on 10/15/2020 to satisfy the full balance.
