Dear Ms. Benitz,

This letter is in response to your letters dated March 6, and March 18, 2019, with response due dates of April 10, and April 22 respectively.

After a few attempts, we successfully completed filing an amended Statement of Organization on March 20, 2019, copy enclosed.

On February 27, 2019, we inadvertently filed a new Statement of Organization when we went online to enroll in the new PAS. When I attempted to login using the password we use to upload and file our FEC 3X, the system responded with a message that we weren't enrolled, and then an enrollment form appeared. I did not know at that time that it was a Statement of Organization that I was completing and filing and I erroneously checked "NEW" rather than "AMENDED". When we were notified on March 7th, we attempted to correct the errors but again made mistakes involving our organization/committee name. Additionally, we were unfamiliar with the electronic/online version of the form and skipped over a few items.

On March 18th, we received the second letter. I had entered our organizational/committee name exactly as it has appeared on the FEC website and how it has appeared on our quarterly Form 3X since we began filing electronically in 2001. We were concerned if was entered differently than what appeared on our reports, it would cause a problem.

When we installed the FECfile software in 2001, the organization/committeee name and FEC ID number were already pre-filled by the FEC. At that period in time, I believe there were character limitations in the software that prevented entering the entire committee name in full.



Finally, on March 20th, the form was completed correctly.

I uninstalled the FECfile software and then downloaded and reinstalled from the FEC website so that we could enter the full name of our committee as shown on the Statement of Organization submitted on March 20<sup>th</sup> and our reports will show the same organization (committee) name.
