Line 21(b) and (c) regarding Federal Operating Expenditures are charges for supplies, secretarial services, use of space, photocopy, and messenger that are billed to the Hogan & Hartson PAC by the law firm of Hogan & Hartson L.L.P. at standard rates charged to clients. Management of the Hogan & Hartson PAC is undertaken by the Treasurer and the Assistant Treasurer who provide their services to the PAC on a volunteer basis.
