The following memo text was attached to a Line 28(a) Memo entry on our October Monthly Report.

*On 2/16/07 we mailed a check to the Oneida Tribe of Indians in the amount of \$2500.00 to refund the amount by which they exceeded their contribution limit in 2006. This was reported on the March Monthly Report on Line 28(a) as a "Refund of amt over contribution limit". In September we learned that they had misplaced this refund check and could no longer deposit it because it was stale dated. They returned the check to us and we provided them with a replacement check for the same amount on 9/20/07. A copy of this check will be mailed to our FEC Analyst to complete the record.*

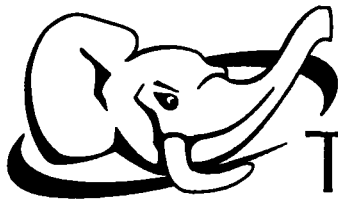

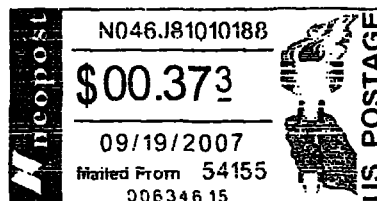
