I am including this cover letter with our amended Statement of Organization as requested by William S. Wiquist. In a letter dated March 24th, 2004, Mr. Wiquist asked us to "clarify your relationship, if any, with My Vote Is My Voice Corporation." In a phone conversation on March 29th, I explained to Mr. Wiquist that since we are the corporation there is no relationship to clarify. He thought the confusion may have been caused by the fact that "Corporation" is in our name, but I explained that this is required by the State of Vermont for nonprofit status, and does not mean we have a connected corporation.. Mr. Wiquist instructed me to clarify that we have no connected or affiliated organizations, committees, or companies in this cover letter.

I am, however, amending our Statement of Organization to state "None" for #6 and to change our web address for #1.
