Committee to Elect Michael Stopa - This committee is registered with the FEC ID # C00486159. The report has been amended to reflect this.

Friends of Alberta Darling - The committee has confirmed that this organization only accepts funds that would be permitted under the Act. The funds received from this committee are federally permissible.

Friends to Elect David Faulkner - Scott Walker, Inc. has confirmed with Friends of David Faulkner that based on reasonable accounting methods, these donations were from federally permissible sources.
