This letter is to supplement the amended Pre-Primary Report filed on June 19, 2012. On line 21 there is a disbursement for \$12,800 to the U.S. Attorney's Office. This letter is to document and further explain that disbursement.

During the 2008 and 2010 campaign cycles the Pete King for Congress Committee received \$12,800 from individuals involved with Full Tilt Poker. The US Attorney's office steed activil forfeiture action against Full Tilt Poker. Attached is a letter with instructions from the US Attorney's office on how to allocate these contributions to compensate the victims of the alleged crimes.

On May 21, 2012 a check for \$12,800 was sent to the USARtorney's Southern District of New York from the Pete King for Congress Committee. This money represents contributions to the Pete King for Congress Committee amounting to \$8,800 from Howard Lederer and \$4,000 from Chris Ferguson. Contribution were:



Dear Congressman King:

This responds to your letter to the Attorney General dated September 22, 2011, regarding the Department of Justice civil lawsuit accusing persons affiliated with the Full Tilt Poker website of defrauding online poker players. We apologize for our delay in replying.

In your letter, you state that as a recipient of campaign contributions from some of the individuals involved in the civil forfeiture action filed by the United States Attorney's Office for the Southern District of New York against Full Tilt Poker and others, *United States v. Poker stars et al.*, 11 Civ. 2564 (S.D.N.Y.), you wish to set aside that money to compensate victims of the alleged crimes. We appreciate your willingness to take this step.

In order to do so, you may issue a check in the appropriate amount payable to "The United States Marshals Service," and note as a reference on the check, "11 Civ. 2564 (S.D.N.Y.)-Forfeiture." Upon receipt of the check, the United States Attorney's Office will complete the necessary paperwork for the check to be received by the Marshals Service and distributed to the victims.
